## **IMPORTANT INFORMATION (*Weapons Regulations 1999 – Prohibited Weapons – Crossbows*)**

The Gosnells Archers Inc. only cater for archers using Compound, Recurve and Longbows, the club is not able to provide facilities for Arbalest and therefore will not support an application for coaching in the use of a crossbow.

The Gosnells Archers Inc. has advised the Minister of Police that we do not have the facilities available for an Arbalest. Therefore any person seeking an exemption under the act by way providing proof of association to the Gosnells Archers, a club affiliated to Archery Australia, and that they own a crossbow for the purposes of taking part in crossbow events or competitions at the club, makes an application in a fraudulent manner.

Any person found to be behaving in such a manner will have their application cancelled and the matter reported to the WA Police.
